PHS Public Cell Station - Digital Network Interface - PHS User-to-User Signalling (PHS-UUS) Supplementary Service -

1. Relations with International Standards.

Based on TTC Standard JT-Q957 [I] Version1 published on Apr. 27th, 1993, this Standard specifies the signalling procedures of PHS User-to-User Signalling (PHS-UUS) Supplementary Service on PHS public cell station - digital network interface along with a policy to keep consistency with interface conditions defined in PHS MoU Specification B-IF2.51 (Version1: established in July, 1998).

2. Additional items to International Standards etc.

The following items have been deleted from or added/modified to TTC Standard JT-Q957 [I].

- (1) Overlap sending, not defined in JT-Q931-b, is out of scope of this Standard.
- (2) Call contention case is out of scope of this Standard because only point-to-point configuration is defined in JT-Q931-b.
- (3) Interaction with supplementary services specifies interaction with PHS supplementary services to have alignment with PHS MoU Specification B-IF2.51. Interaction with inter connection charge billing system supplementary services defined in JT-Q932-a is specified in addition to PHS MoU Specification IF2.51.
- (4) Interaction with other networks specifies interaction with other PHS networks and interaction with ISDN networks to have alignment with PHS MoU Specification B-IF2.51.
- (5) The terms of TTC Standard JT-Q957 [I] shall be replaced with those of this Standard as shown in the following table.

- (5) Only PHS-UUS Service 1 implicit request is standardised. Other services (PHS-UUS Service 1 explicit request, Service 2, Service 3) is out of scope of this standard.
