WTSA-12

The World Telecommunication Standardization Assembly) is held every four years and defines the next period of study for ITU-T.

WTSA-12 took place 20-29 November 2012 in Dubai, United Arab Emirates.

WTSA-12 resolves to establish a **Review Committee** (RC) and the procedures and the terms of reference as described in Annex A of **Resolution 82**.

Background of Resolution on Strategic and structural review of ITU-T

- 1) Overall coordination of JCAs, FGs, and other ITU-T groups might be needed.**
- 2) In terms of the structure of ITU-T, Study Groups should be restructured and/or current structural arrangements including the purpose and objectives of JCAs, GSIs, TSRs, FGs, etc. should be examined.**
- 3) There is a need to consider improvements in coordination and collaboration arrangements between ITU-T and ITU-R, ITU-D, other standards making entities, and other relevant entities, while avoiding overlap with TSAG functions.**

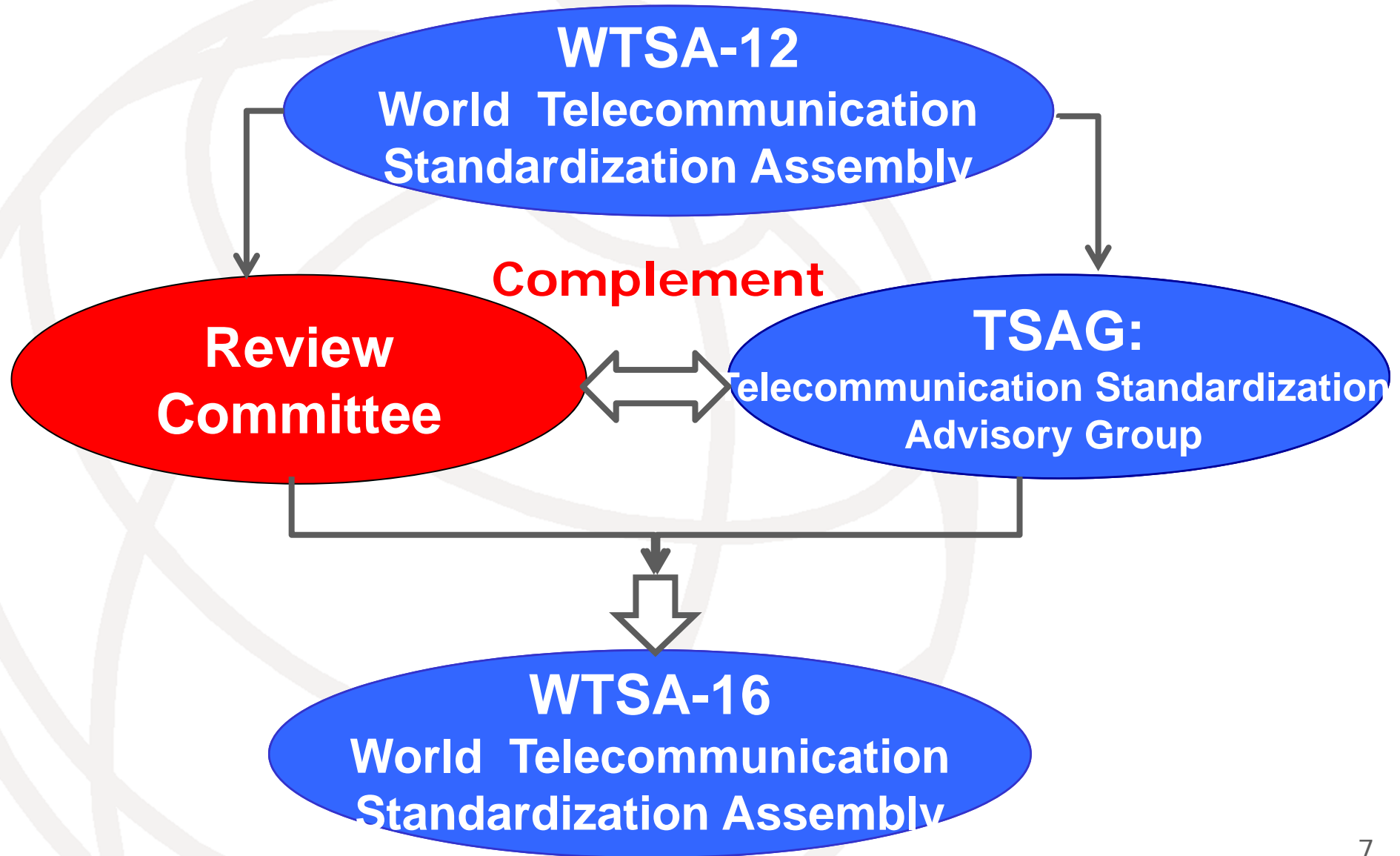
Instructions for the RC

- 1) to report to TSAG on a regular basis;
- 2) to consider the outcomes of the CTO meetings, in particular their reports;
- 3) to conduct its initial review in a timely manner so as to provide input to TSAG for the preparation of the ITU-T's strategic plan;
- 4) to submit its report to next WTSA through TSAG.

Instructions for TSAG

- 1) to consider the Review Committee progress reports and in conformity with CV Art. 14A implementing, as appropriate, any recommendations pending consideration at next WTSA,
- 2) to submit the final report of the Review Committee, without changes, to WTSA together with its comments thereto.

Review Committee and TSAG



Key Actions for the RC – Part 1

- 1) Examine the adequacy of the current structure of the ITU-T to meet the market.
- 2) Review the current coordination and collaborations mechanisms with other standards bodies.
- 3) Review existing models for collaboration between ITU-T and other standards bodies.
- 4) Identify and propose new modalities for cooperation.
- 5) Identify ways and means to enhance cooperation with standard.
- 6) Develop and propose recommendations for a set of principles for standards development within ITU-T

Key Actions for the RC – Part 2

- 7) Develop a work plan by which to conduct the review and structure of the report.
- 8) Provide input to TSAG for the preparation of the ITU-T's strategic plan.
- 9) Present its report to WTSA-16 without changes through TSAG.
- 10) Report its progress to TSAG on a regular basis and take into account the comments made by TSAG on the progress report.
- 11) Provide reports to TSAG, identifying any specific actions which could be undertaken or implemented in the near term.

Meeting schedule for the RC

- 1) RC shall meet immediately prior to TSAG.
- 2) The duration of each review committee meeting shall not exceed three days.
- 3) The final report of the RC shall be translated and made available to the final TSAG meeting before WTSA-16.
The review committee shall end in 2016 unless WTSA-16 decides to renew it.

The first RC meeting will be held on **3rd June 2013** in Geneva. The RC management meeting will be held on **31st May 2013** with remote participation.
